

सॉवरिन वेल्थ फंडों (एसडब्ल्यूएफ) और पेंशन फंडों द्वारा होटल, कोल्ड चैन, शिक्षण संस्थानों, अस्पतालों, गैस पाइपलाइन जैसे 34 प्रमुख बुनियादी ढांचा क्षेत्रों में निवेश पर कुछ निश्चित आमदनी पर कर छूट का प्रावधान किया गया है।

## संसदीय समितियों की बैठक शुरू

नई दिल्ली, 7 जुलाई

संसद की स्थायी समितियों की बैठकें फिर से शुरू हो गई हैं। इसके साथ ही मंगलवार को राज्यसभा सचिवालय ने इन बैठकों के लिए आठ बिंदु वाले प्रोटोकॉल का पालन करने की घोषणा की है। वहीं दूसरी तरफ संसद सदस्यों ने संसदीय समिति की वर्चुअल बैठक की मांग की है। कई सांसदों ने कहा है कि वे यात्रा प्रतिबंधों, क्वारंटीन और दूसरी दिक्कतों के कारण दिल्ली में होने वाली बैठकों में शामिल नहीं हो पाएंगे। समितियों के प्रमुखों को आशंका है कि बैठक शुरू करने के लिए न्यूनतम सदस्यों की संख्या (कोरम या गणपूर्ति) भी पूरी नहीं हो पाएगी। विभाग से संबंधित 24 संसदीय स्थायी समितियां हैं, जिनमें से आठ राज्यसभा के अंतर्गत आती हैं जबकि बाकी लोकसभा के अधीन हैं।

राज्यसभा की समितियों में से एक कांग्रेस नेता जयराम रमेश की अध्यक्षता वाली विज्ञान, प्रौद्योगिकी पर्यावरण और वन संबंधी समिति की बैठक 10 जुलाई को होनी है जबकि कांग्रेस नेता आनंद शर्मा के नेतृत्व वाली गृह मामलों की समिति की बैठक 15 जुलाई को होनी है। दोनों समितियों ने कोविड-19 महामारी से जुड़े विभिन्न पहलुओं की जांच करने का फैसला किया है।

राज्यसभा सचिवालय ने अपने अधीन आने वाली समिति की बैठकों के लिए सामाजिक दूरी के नियमों के मानदंड भी जारी किए हैं। लोकसभा की पेट्रोलियम और प्राकृतिक गैस पर संसद की स्थायी समिति की बैठक मंगलवार को हो रही है जहां मंत्रालय के अधिकारी सांसदों को ‘राष्ट्रीय गैस ग्रीड’ और तेल मार्केटिंग कंपनियों के प्रदर्शन की समीक्षा करेंगे।

राज्यसभा के सभापति एम वेंकैया नायडू को लिखे पत्र में विज्ञान एवं प्रौद्योगिकी समिति के प्रमुख जयराम रमेश ने कहा कि सभी दलों के सांसदों ने कोविड-19 से संबंधित मुद्दों पर चर्चा के लिए उनकी समिति की वर्चुअल बैठक कराने को कहा है। रमेश ने कहा कि ‘निश्चित रूप से’ वर्चुअल बैठकों का इंतजाम किया जा सकता है क्योंकि कई अन्य देशों ने भी वर्चुअल तरीके से ही पूरे संसद सत्र का भी आयोजन किया। उन्होंने कहा, ‘मुझे उम्मीद है कि आपकी अनुमति मिलेगी।’ जहां इच्छाशक्ति होती है वहां कौशल भी होता है।’ उन्होंने कहा कि कई सांसदों ने यात्रा प्रतिबंधों के कारण इन बैठकों में भाग लेने में असमर्थता जताई है। उन्होंने कहा, ‘मुझे संदेह है कि हम इन बैठकों के लिए जरूरी न्यूनतम संख्या भी जुटा पाएंगे।’

## आरोग्य संजीवनी में बीमा की सीमा हटी

मानक स्वास्थ्य बीमा पॉलिसी के दायरे में विस्तार करने के लिए प्रत्येक सामान्य बीमाकर्ताओं और स्वास्थ्य बीमाकर्ताओं को आरोग्य संजीवनी नाम से योजना उतारने की सिफारिश की गई थी। बीमा नियामक ने बीमा कंपनियों को बीमित राशि तय करने की स्वच्छंदता दे दी है। इसके बाद अब कंपनियां बीमाकर्ताओं को पॉलिसीधारकों के समक्ष पहले से निर्धारित बीमित राशि की सीमा से कम और अधिक की पेशकश करने के लिए कह सकती हैं।

नियामक ने अब कहा है कि बीमाकर्ता पॉलिसी के लिए 1 लाख रुपये से कम और 5 लाख रुपये की ऊपरी सीमा से अधिक की बीमित राशि की पेशकश कर सकते हैं। नियामक ने इस साल जनवरी में मानक स्वास्थ्य उत्पाद के लिए जो दिशानिर्देश जारी किए थे उसमें बीमित राशि की न्यूनतम सीमा 1 लाख रुपये और अधिकतम सीमा 5 लाख रुपये तय की गई थी। बीमा नियामक ने कहा, ‘आम जनता को और अधिक सुविधा देने के लिए बीमाकर्ताओं को न्यूनतम बीमित राशि के लिए व्यापक दायरा अधिकतम राशि 5 लाख रुपये से

अधिक की पेशकश करने की अनुमति दी जाती है। बीमित रकम का निर्धारण बीमाकर्ताओं के जोखिम अंकन नीति के अधीन होगी। बीमित रकम का विकल्प केवल 50,000 रुपये के गुणज में ही होगा।’ बजाज आलियांज जनरल इंश्योरेंस के प्रबंध निदेशक और मुख्य कार्याधिकारी तपन सिंघल ने कहा, ‘ग्राहकों के पास चुनाव का जितना अधिक विकल्प होता है उतने ही अच्छे तरीके से वे अपनी जरूरत के मुताबिक कवर का चुनाव कर पाते हैं। इस कदम से बीमाकर्ताओं के पास बीमित राशि के लिए व्यापक दायरा मौजूद होगा।’

## हरियाणा में स्थानीय लोगों को आरक्षण

हरियाणा अब भारत के उन आधे दर्जन राज्यों में शामिल हो गया है, जहां उद्योग को स्थानीय लोगों की नियुक्ति अनिवार्य है। अभी इस प्रस्ताव को अंतिम रूप दिया जाना है, लेकिन सरकार ने उस अध्यादेश पर कैबिनेट की मंजूरी ले ली है, जिसमें निजी क्षेत्र के रोजगार में हरियाणा के स्थानीय निवासियों के लिए 70 प्रतिशत आरक्षण अनिवार्य किया गया है।

हरियाणा की फैक्टरियों से विस्थापितों की वापसी और महामारी के बीच हरियाणा स्टेट इंप्लाइमेंट आफ लोकल कैंडिडेट्स ऑर्डिनंस 2020 का असर यह होगा कि अब हरियाणा के बाहर के लोगों की राज्य में नौकरी सुरक्षित नहीं रहेगी। हरियाणा विस्थापित श्रमिकों की कमी का लाभ उठा रहा है और स्थानीय श्रम बल को निजी क्षेत्र में रोजगार के लिए पेशकश कर रहा है। भारतीय जनता पार्टी (भाजपा) और जननायक जनता पार्टी (जजपा) के नेता और राज्य के उप मुख्यमंत्री दुष्यंत चौटाला दोनों ने ही चुनावी घोषणापत्र में स्थानीय लोगों को नौकरियों में आरक्षण देने का वादा किया था। यह नियम नई इकाइयों पर लागू होगा, न कि मौजूदा इकाइयों पर, लेकिन

इस तरह का आरक्षण दिया गया है, लेकिन इसकी सफलता अलग अलग है। गुजरात ने 1985 में निजी क्षेत्र में 85 प्रतिशत स्थानीय लोगों को नौकरियों में आरक्षण का प्रावधान दिया था और कर्मचारी की श्रेणी और सुपरवाइजर स्तर पर 90 प्रतिशत से ज्यादा स्थानीय लोग नौकरी करते हैं। कांग्रेस नेता कमलनाथ की सरकार ने मध्य प्रदेश में स्थानीय लोगों को निजी क्षेत्र में 70 प्रतिशत आरक्षण देने का प्रस्ताव किया था। लेकिन राज्य के वित्त मंत्री जयंत मलैया ने प्रस्ताव का स्वागत करते हुए इसकी समस्याओं की ओर ध्यान दिलाते हुए कहा था, ‘में

इसकी वजह से बिहार, बंगाल और अन्य राज्यों खासकर आतिथ्य क्षेत्र में बड़े पैमाने पर काम कर रहे पूर्वोत्तर के विस्थापित लोगों की नौकरियों की चिंता बढ़ गई है। इस साल फरवरी महीने में कर्नाटक सरकार ने कानून का मसौदा तैयार करने की कवायद की थी, जिसमें निजी उद्योगों सहित विभिन्न क्षेत्रों में स्थानीय लोगों को 75 प्रतिशत आरक्षण दिया जाना अनिवार्य था। हालांकि यह सभी उद्योगों पर नहीं लागू होना था। कर्नाटक इंप्लाइमेंट आफ लोकल कैंडिडेट्स इन फैक्टरीज शांप्स, कर्माशियल स्ट्रेबलिशमेंट्स, एमएसएमई ऍंड ज्वांट वेंचर्स बिल में उन लोगों को स्थानीय के रूप में परिभाषित किया गया है, जो कर्नाटक में 15 साल से रह रहे हों और उन्हें कन्नड़
